<u>Additional requirements for Simple</u> <u>Infrastructure Projects</u>:

i. <u>The Organized CSG's computation of Net</u> <u>Financial Contracting Capacity (NFCC)</u>, where the values of the CSG's current assets and current liabilities shall be based on the latest AFS submitted to the BIR. The computation of a CSG's NFCC must be at least equal to the ABC of the Community-based Project, calculated as follows:

NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under ongoing contracts, including awarded contracts yet to be started, coinciding with the contract to be bid.
