



BAC Resolution No. 64, Series of 2022

Procurement of supply and delivery for food and accommodation

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of supply and delivery for food and accommodation with an Approved Budget for the Contract (ABC) of Ninety Five Thousand Pesos Only (Php 95,000.00).

WHEREAS, on Feb. 10, 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: : (1) KISSES FOODHAUZ & CATERING SERVICES; (2) ALILY'S CATERING SERVICES; (3) CARAJAY CATERING SERVICES.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on Feb. 14, 2022, KISSES FOODHAUZ & CATERING SERVICES, ALILY'S CATERING SERVICES, and CARAJAY CATERING SERVICES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, KISSES FOODHAUZ & CATERING SERVICES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2022 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, the TWG likewise determined that the financial proposal submitted by KISSES FOODHAUZ & CATERING SERVICES in the amount of Ninety Five Thousand Pesos Only (Php 95,000.00) is the lowest quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Procurement of supply and delivery for food and accommodation to KISSES FOODHAUZ & CATERING SERVICES in the amount of Ninety Five Thousand Pesos Only (Php 95,000.00).








