RESOLUTION NO. Series of 2022

WHEREAS, the Department of Agriculture has a Purchase Request for One Job Order for a 30minute airtime services to be aired on a commercial radio station in the Province of Aklan with a total budget under GAA for Approved Budget for the Contract in the amount of Two Hundred Seventy-Five Thousand Pesos Only (Php 275,000.00);

WHEREAS, the End-user has conducted a market study and has determined a number of service providers in the Province of Aklan;

WHEREAS, there are four AM radio stations and 15 active FM radio stations operating in the Province of Aklan;

WHEREAS, DYKR-RMN, Kalibo, Aklan/Radio Mindanao Network, Inc. operates at 10,000 watts wherein it can reach a 120-kilometer radius where majority of the farmers live. It can also reach neighboring Provinces of Capiz, Mindoro, Masbate, and Palawan;

WHEREAS, DYKR-RMN, Kalibo, Aklan/Radio Mindanao Network, Inc. is considered as one of the top stations in the AM band in Aklan and is patronized by advertisers in metro Kalibo and farmers in the rural areas;

WHEREAS, DYKR-RMN, Kalibo, Aklan/Radio Mindanao Network, Inc. offers a 30-minute block time at a very reasonable and affordable cost of P25,000.00 per month;

WHEREAS, DYKR-RMN, Kalibo, Aklan/Radio Mindanao Network, Inc. has established partnership with the DA western Visayas on its sponsored *Kadalag-an sang Agrikultura* Radio farm Program aired every 5:00 to 5:30 in the afternoon Tuesday and Thursday for the past 17 years;

WHEREAS, series of School-on-the-Air (SOAs), a distant learning program featuring focused and priority commodities of banner programs such as *Palayamanan, PalayCheck*, Integrated pest Management, Coffee Production, Banana Production, Organic Agriculture and livestock and Poultry technology were conducted. The conduct of SOA usually ranges from three to four months intensive lectures of the specific topic by SOA Professors and Focal Persons and was hosted by the provincial farm caster;

WHEREAS, the recent SOA conducted was on Unified School on the Air on Smart Rice Agriculture in collaboration with the Agricultural Training Institute and Provincial government of Aklan which started last May 2021, and culminated on November 16, 2021. We have 500 farmerenrollees from the different municipalities of the Province of Aklan;

WHEREAS, through these SOAs, we have established a pool of radio listeners consisting of ordinary farmers, livestock raisers, fisher folks, students, entrepreneurs and professionals who are interested and are practicing farming in their respective areas;

To recommend the award of contract through Negotiated Procurement for Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services for the "One Job Order for a 30-minute airtime services to be aired on a commercial radio station in the Province of Aklan" with a price quotation of Two Hundred Seventy-Five Thousand Pesos Only (Php 275,000.00) to DYKR-RMN, Kalibo, Aklan/Radio Mindanao Network, Inc.;
- c.) To recommend for approval by the Regional Executive Director of Department of Agriculture Regional Field Unit No. 6 of the foregoing findings.
