Lease of Venue with food for the conduct of Briefing/Orientation of Project Staff and Enumerators on Feb. 8, 2022 in the Province of Capiz

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with food for the conduct of Briefing/Orientation of Project Staff and Enumerators on Feb. 8, 2022 in the Province of Capiz with an Approved Budget for the Contract (ABC) of Twelve Thousand Five Hundred Pesos Only (Php 12,500.00).

WHEREAS, on Jan. 26, 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: : (1) MVW RESTAURANT & TOURIST INN; (2) NESTA'S HILLTOP HOTEL & RESTAURANT; (3) NECIE'S HOTEL.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on Jan. 31, 2022, MVW RESTAURANT & TOURIST INN, NESTA'S HILLTOP HOTEL & RESTAURANT, and NECIE'S HOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, NESTA'S HILLTOP HOTEL & RESTAURANT is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2022 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, the TWG likewise determined that the financial proposal submitted by NESTA'S HILLTOP HOTEL & RESTAURANT in the amount of Twelve Thousand Four Hundred Twenty Five Pesos Only (Php 12,425.00) is the lowest quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE,

for her consideration and approval, the award of contract for the Lease of Venue with food for the conduct of Briefing/Orientation of Project Staff and Enumerators on Feb. 8, 2022 in the Province of Capiz to NESTA'S HILLTOP HOTEL & RESTAURANT in the amount of Twelve Thousand Four Hundred Twenty Five Pesos Only (Php 12,425.00).
