Procurement of supply and delivery for the lay outing, editing, and printing

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of supply and delivery for the lay outing, editing, and printing with an Approved Budget for the Contract (ABC) of Eighty Thousand Pesos Only (Php 80,000.00).

WHEREAS, on Jan. 24, 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to seven (7) prospective suppliers, viz: : (1) D. SALARDA PRINTING PRESS; (2) BAMA PRINTING PRESS; (3) NO BOUNDARIES ADVERTISING AND EVENTS; (4) HOMETOWN PRINTING PRESS; (5) AG3 COLORS PRINTING PRESS; (6) KING PHIL PRINTING SERVICES; (7) MAKINAUGALINGON PRINTER & BOOKBINDER

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on Jan. 31, 2022, D. SALARDA PRINTING PRESS, BAMA PRINTING PRESS, NO BOUNDARIES ADVERTISING AND EVENTS, HOMETOWN PRINTING PRESS, AG3 COLORS PRINTING PRESS, KING PHIL PRINTING SERVICES and MAKINAUGALINGON PRINTER & BOOKBINDER submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary NO BOUNDARIES ADVERTISING AND EVENTS and HOMETOWN PRINTING PRESS complied with the specification and other forms and conditions stated in the Request for Quotations and quoted the same price in the amount of Seventy Eight Thousand Four Hundred Pesos Only (Php 78,400.00); which is advantageous to the government.

WHEREAS, under RA 9184 a tie breaking process by toss coin is authorized;

WHEREAS, a tie breaking process was conducted last Feb. 18, 2022 at 9:00 A.M. at RCPC Library, WESVIARC, Hamungaya, Jaro, Iloilo City. During the process by toss coin NO BOUNDARIES ADVERTISING AND EVENTS emerged as the winner.
