**WHEREAS**, the conditions enumerated in Annex "H" of the 2016 revised IRR of RA 9184 are met by the servicing agency;


**NOW, THEREFORE**, we the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- b.) To recommend for approval of the Regional Executive Director of the Department of Agriculture RFO 6 the award of the said contract.







