

BAC Resolution No. 60, Series of 2022

Lease of Venue with food and accommodation during the conduct of SAAD Program Quarter 2
Assessment Review on June 23-24, 2022 in Bacolod City

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with food and accommodation during the conduct of SAAD Program Quarter 2 Assessment Review on June 23-24, 2022 in Bacolod City with an Approved Budget for the Contract (ABC) of Ninety Four Thousand Pesos Only (Php 94,000.00).

WHEREAS, on Feb. 4, 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) L'FISHER HOTEL BACOLOD; (2) O HOTEL; (3) ACACIA HOTEL BACOLOD (BREDCO).

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on Feb. 11, 2022, L'FISHER HOTEL BACOLOD, O HOTEL, and ACACIA HOTEL BACOLOD (BREDCO) submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirement, all three submitted quotations have the same price offered and within the ABC. However, in terms of submission of the required documents ACACIA HOTEL BACOLOD (BREDCO) is the most compliant and passed the specifications under the Table of Rating Factor (Appendix C).

WHEREAS, the TWG likewise determined that the financial proposal submitted by ACACIA HOTEL BACOLOD (BREDCO) in the amount of Ninety Four Thousand Pesos Only (Php 94,000.00) is the most responsive quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Lease of Venue with food and accommodation during the conduct of SAAD Program Quarter 2 Assessment Review on June 23-24, 2022 in Bacolod City to ACACIA HOTEL BACOLOD (BREDCO) in the amount of Ninety Four Thousand Pesos Only (Php 94,000.00).
