



BAC Resolution No. 77 Series of 2022

RECOMMENDING AWARD OF CONTRACT FOR THE LEASE OF VENUE WITH FOOD AND ACCOMMODATION DURING THE CONDUCT OF AGRICULTURAL INFORMATION CARAVAN IN LANJAGAN, AJUY, ILOILO

WHEREAS, the Department of Agriculture has a Purchase Request for the **Lease of Venue with Food and Accommodation during the Conduct of Agricultural Information Caravan in Lanjagan, Ajuy, Iloilo** with an Approved Budget for the Contract (ABC) in the amount of **Ninety Thousand Pesos Only (Php 90,000.00)**;

WHEREAS, on 17 February 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) SEAMAN'S GRILL AND RESTO; (2) CONCEPCION EMPOWERED WOMEN ASSOCIATION; (3) GARILVA RECREATION CENTER;

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on 21 February 2022, SEAMAN'S GRILL AND RESTO, CONCEPCION EMPOWERED WOMEN ASSOCIATION and GARILVA RECREATION CENTER submitted their quotations;

WHEREAS, upon careful evaluation, validation and verification of all the documentary requirements and specification stated in the Request for Quotation, **GARILVA RECREATION CENTER** is considered as the responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2022 Mayor's/Business Permit and PhilGEPS Registration Number and passed the specifications under table of Rating Factors (Appendix C);

WHEREAS, the TWG likewise determined that the financial proposal submitted by **GARILVA RECREATION CENTER** in the amount of **Eighty-Eight Thousand Pesos Only (Php 88,000.00)** is the lowest calculated quotation;

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant;


WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof;






