

RECOMMENDING AWARD OF CONTRACT FOR LEASE OF VENUE WITH FOOD AND ACCOMMODATION DURING THE CONDUCT OF INVENTORY AND MANAGEMENT TRAINING FOR PRDP-IREAP BENEFICIARIES IN ILOILO CITY

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation during the Conduct of Inventory and Management Training for PRDP-IREAP Beneficiaries in Iloilo City with an Approved Budget for the Contract (ABC) in the amount of Ninety Thousand Pesos Only (Php 90,000.00);

WHEREAS, on 21 February 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) CIRCLE INN HOTELS & SUITES; (2) MO2 WESTOWN HOTEL; (3) ZURI HOTELS & SUITES;

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on 28 February 2022, CIRCLE INN HOTELS & SUITES, MO2 WESTOWN HOTEL and ZURI HOTELS & SUITES submitted their quotations;

WHEREAS, CIRCLE INN HOTELS & SUITES and MO2 WESTOWN HOTEL offered higher than the Approved Budget for the Contract (ABC);

WHEREAS, upon careful evaluation, validation and verification of all the documentary requirements and specification stated in the Request for Quotation, ZURI HOTELS & SUITES is considered as the responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2022 Mayor's/Business Permit and PhilGEPs Registration Number and passed the specifications under table of Rating Factors (Appendix C);

WHEREAS, the TWG likewise determined that the financial proposal submitted by ZURI HOTELS & SUITES in the amount of One Hundred Forty-Three Thousand Five Hundred Pesos Only (Php 143,500.00) is the lowest calculated quotation;

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant;

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof;

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPF, for her consideration and approval, the award of contract for the Lease of Venue with Food and Accommodation during the Conduct of Inventory and Management Training for PRDP-IREAP Beneficiaries in Iloilo City to ZURI HOTELS & SUITES in the amount of One Hundred Forty-Three Thousand Five Hundred Pesos Only (Php 143,500.00).
