WHEREAS, the Department of Agriculture RFO VI advertised the Invitation to bid for the **Procurement of Works for the Establishment of Five (5) units Greenhouse Facility (with Automated Micro-Sprinkler Irrigation System) (Lot 2)** in the DA RFO VI website, in PhilGEPS website and a conspicuous place at the premises of DA RFO VI continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 2,500,000.00**;




