(Resolution to Declare the Responsive Bidder)

**WHEREAS**, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the Procurement of Supply and Delivery of Various NSIC Approved Hybrid Rice Seeds in the DA-Western Visayas website, the PhilGEPs and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php 3,000,000.00;

**WHEREAS**, in response to the said advertisement, two (2) bidders submitted its application for eligibility and bid offer;

**WHEREAS**, the two (2) bidders "passed" the preliminary examination of bid;

NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED;




