(Resolution to Declare the Responsive Bidder)

**WHEREAS**, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the Procurement of Supply and Delivery of Organic Fertilizer in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php1,227,500.00;

**WHEREAS**, in response to the said advertisement, two (2) bidders submitted its application for eligibility and bid offer;

**WHEREAS**, the two (2) bidders "passed" the preliminary examination of bid;

**WHEREAS**, the bid proposal of the two (2) bidders were found to be substantially complying:



**NOW, THEREFORE, WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;



- b. To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings.




