NOTICE FOR RENEGOTIATED PROCUREMENT

The Department of Agriculture, Regional Field Office No. 6, Iloilo City invites all contractors to participate in the **RENEGOTIATION** for the **Procurement of Works for the Construction of Production Facility with Complete Accessories** to be constructed at **Brgy. Jolongajog, Pontevedra, Capiz**.

ABC: One Million Three Hundred Eighty-Six Thousand One Hundred Thirty-Seven Pesos and 80/100 (Php 1,386,137.80)

Completion of Works is required **within 67 calendar days** from receipt of Notice to Commence. Must adopt the corporate color of the painting of the structure (**Green, Yellow Gold and Chocolate Brown**).

Interested Contractors must submit requirements for accreditation in order to participate in the negotiation for said procurement.

Deadline for submission of documents for accreditation and offer is on or before **1:00 P.M., April 04, 2022** at the **RCPC Library, DA-WESVIARC Compound, Brgy Buntatala, Jaro, Iloilo City**.

REQUIREMENTS FOR ACCREDITATION

“Class A Documents”

1. **Platinum PhilGEPS** Certificate of Registration and Membership (**including annexes**). In case of joint venture, each partner shall submit their respective PhilGEPS Certificate of Registration;

Technical Documents

2. Statement of all its on-going government and private contracts, including contracts awarded but not yet started if any whether similar or not similar in nature and complexity to the contract to be bid.
3. Statement of the Bidder’s Single Largest Completed Contract (SLCC) covering the period 2019-2021 that is similar to the contract to be bid.

The **two** statements shall include, for each contract, the following:

- 3.1) Name of contract
- 3.2) Date of the contract
- 3.3) Contract duration
- 3.4) Owner’s name and address
- 3.5) Nature of work
- 3.6) Contractor’s role (whether sole contractor, subcontractor or partner in a JV) and percentage of participation
- 3.7) Total contract value at award
- 3.8) Date of completion or estimated completion time
- 3.9) Total contract value at completion, if applicable
- 3.10) Percentages of planned and actual accomplishments, if applicable
- 3.11) Value of outstanding works, if applicable
- 3.12) The statement

3.12.2) SLCC – amount of completed contract and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC. However, contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB

3.12.3) The SLCC shall be supported by:

- Notice of Award and/or Notice to Proceed
- Contract/Purchase Order (PO)

4. Latest income and business tax returns per Revenue Regulations 3-2005;

a) If the filing of the business and income tax returns is joint as in BIR Form No. 1701, the combined tax returns must be for the period ending December 31, 2020.

b) If the filing is not joint as in BIR Form No. 1702, the income tax return must be for the period ending December 31, 2020 and the business tax return must cover the 3rd quarter of 2021 or September 30, 2021.

5. **Valid PCAB License and valid Registration.** In case of Joint Venture, a Special PCAB License and Registration.

Class “B” Documents

1. If applicable, valid Joint Venture Agreement (JVA) shall be submitted.
2. **Sworn Statement** by the prospective bidder or its duly authorized representative in the form prescribed by the GPPB as to the following:
 - a) It is not “blacklisted” or barred from bidding by the GOP or any of its agencies, offices, corporations or LGUs, including foreign government/foreign or international financing institution whose blacklisting rules have been recognized by the GPPB;
 - b) Sworn affidavit of the bidder that it is not related to the HOPE, members of the BAC, the TWG, BAC Secretariat, the head of the Project Management Office or end-user unit by consanguinity or affinity up to the third civil degree.

2. Duly signed Detailed Estimates/Bill of Materials (It **must be signed and sealed by a licensed Civil Engineer and licensed Agricultural & Biosystems Engineer**)
3. Duly signed Cash Flow by Quarter and Payments Schedule
