Under Proclamation no. 1267

RESOLUTION NO. 07
Series of 2022

WHEREAS, the President of the Philippines issued Proclamation no. 1267 Declaring a State of Calamity in Regions IV-B, VI, VII, VIII, X and XIII ;

WHEREAS, the declaration of the State of Calamity will hasten the rescue, relief, and rehabilitation efforts of the Government and private sector, including any international humanitarian assistance;

WHEREAS, this declaration will among others effectively control the prices of basic goods and commodities in the affected areas, and afford the National Government, as well as local government units (LGUs), ample latitude to utilize appropriate funds for the rescue, recovery, relief, and rehabilitation of, and the continuation of basic services to, affected populations, in accordance with law;

WHEREAS, all departments and other concerned government agencies are hereby directed to implement and execute rescue, recovery, relief, and rehabilitation work in accordance with pertinent operational plans and directives;

WHEREAS, the Secretary of the Department of Agriculture issued Memorandum dated December 28, 2021, the subject of which is 2022 Marching Orders and Way Forward, Major Burning Issues, and Rehabilitation and Recovery Plan for Typhoon Odette-Affected Regions, more than ensuring national food security in these difficult times, but more purposely ensuring performance of the agriculture sector to grow and our farmers and fisherfolks to prosper;

WHEREAS, Republic Act 9184 and its Revised Implementing Rules and Regulation allows Negotiated Procurement during Emergency Cases when time is of the essence arising from natural or man-made calamities;

WHEREAS, under Negotiated Procurement through emergency cases the BAC shall undertake the Negotiation with the supplier with technical, legal and financial capability to deliver the goods to be procured;

WHEREAS, a Purchase Request for **Supply and Delivery of 26 Heads Cattle** with ABC of **Php1,040,000.00** will be undertaken for the purpose of this procurement;

WHEREAS, the Bids and Awards Committee (BAC) Negotiated the Procurement for the Supply and Delivery of 26 heads Cattle to **AMARANTE LIVESTOCK TRADING** who has the technical, financial capability to deliver the items to be procured;



NOW, THEREFORE, we the members of the Bids and Awards Committee,(BAC) hereby **RESOLVE** as it is hereby **RESOLVED**:






