BAC Resolution No. 154 Series of 2022

RECOMMENDING AWARD OF CONTRACT FOR THE LEASE OF VENUE WITH FOOD AND ACCOMMODATION DURING THE CONDUCT OF CORN AND CASSAVA CLUSTER DEVELOPMENT TRAINING IN THE PROVINCE OF ILOILO

WHEREAS, the Department of Agriculture has a Purchase Request for the **Lease of Venue with Food and Accommodation during the Conduct of Corn and Cassava Cluster Development Training in the Province of Iloilo** with an Approved Budget for the Contract (ABC) in the amount of **Four Hundred Fifteen Thousand Pesos Only (Php 415,000.00)**;

WHEREAS, on 02 March 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) DIVERSION 21 HOTEL; (2) DISTRICT 21 HOTEL; (3) EON CENTENNIAL RESORT HOTEL & WATERPARK;

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on 09 March 2022, DIVERSION 21 HOTEL, DISTRICT 21 HOTEL and EON CENTENNIAL RESORT HOTEL & WATERPARK submitted their quotations;

WHEREAS, upon careful evaluation, validation and verification of all the documentary requirements and specification stated in the Request for Quotation, **EON CENTENNIAL RESORT HOTEL & WATERPARK**, however is not compliant with the technical specifications specifically in the availability of Elevator. The technical Working Group (TWG) proceeded in the evaluation of the second lowest offeror, **DIVERSION 21 HOTEL** which was found to be compliant with the agency specifications, with price quotation within the ABC and was found to be compliant with the eligibility requirements as evidenced by the submission of its 2022 Mayor's/Business Permit and PhilGEPS Registration Number and passed the specifications under table of Rating Factors (Appendix C);

WHEREAS, the TWG likewise determined that the financial proposal submitted by **DIVERSION 21 HOTEL** in the amount of **Four Hundred Thirteen Thousand Five Hundred Pesos Only (Php 413,500.00)** is the lowest calculated quotation;

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant;


WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof;


NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the **Lease of Venue with Food and Accommodation during the Conduct of Corn and Cassava Cluster Development Training in the Province of Iloilo** to **DIVERSION 21 HOTEL** in the amount of **Four Hundred Thirteen Thousand Five Hundred Pesos Only (Php 413,500.00)**.




