BAC Resolution No. 163, Series of 2022

**Lease of Venue with food and accommodation during the conduct of Training on RCM use and Operation on June 15-17, 2022 & June 22-24, 2022 in Iloilo City**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of Venue with food and accommodation during the conduct of Training on RCM use and Operation on June 15-17, 2022 & June 22-24, 2022 in Iloilo City with an Approved Budget for the Contract (ABC) of Three Hundred Four Thousand Pesos Only (Php 304,000.00).

**WHEREAS**, on Mar. 2, 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) GOLDBERRY LITE HOTEL; (2) MO2 WESTOWN HOTEL; (3) EON CENTENNIAL RESORT HOTEL & WATERPARK.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 12:00 noon. on Mar. 9, 2022, GOLDBERRY LITE HOTEL, MO2 WESTOWN HOTEL, and EON CENTENNIAL RESORT HOTEL & WATERPARK submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements EON CENTENNIAL RESORT HOTEL & WATERPARK is considered as the lowest offeror and price within ABC. However, the said offeror is not compliant to the technical specifications prepared by the end user. Therefore considered as non-responsive.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, GOLDBERRY LITE HOTEL is considered as the second lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2022 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, the TWG likewise determined that the financial proposal submitted by GOLDBERRY LITE HOTEL in the amount of Three Hundred Two Thousand Five Hundred Pesos Only (Php 302,500.00) is the second lowest responsive quotation.

**WHEREAS**, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.




