



RECOMMENDING AWARD OF CONTRACT FOR THE LEASE OF VENUE WITH FOOD AND ACCOMMODATION DURING THE CONDUCT OF ASSESSMENT AND PLANNING WORKSHOP FOR THE FOOD TERMINALS (BFTS/MFTS) PROJECT IN ILOILO CITY

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation during the Conduct of Assessment and Planning Workshop for the Food Terminals (BFTs/MFTs) Project in Iloilo City with an Approved Budget for the Contract (ABC) in the amount of Eighty-Two Thousand Two Hundred Fifty Pesos Only (Php 82,250.00);

WHEREAS, on 02 March 2022, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) EON CENTENNIAL PLAZA HOTEL; (2) CIRCLE INN; (3) MO2 WESTOWN HOTEL;

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on 09 March 2022, EON CENTENNIAL PLAZA HOTEL, CIRCLE INN and MO2 WESTOWN HOTEL submitted their quotations;

WHEREAS, EON CENTENNIAL PLAZA HOTEL and CIRCLE INN offered an amount higher than the Approved Budget for the Contract (ABC);

WHEREAS, upon careful evaluation, validation and verification of all the documentary requirements and specification stated in the Request for Quotation, MO2 WESTOWN HOTEL is considered as the responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2022 Mayor's/Business Permit and PhilGEPS Registration Number and passed the specifications under Table of Rating Factors (Appendix C);

WHEREAS, the TWG likewise determined that the financial proposal submitted by MO2 WESTOWN HOTEL in the amount of Eighty-Two Thousand Two Hundred Fifty Pesos Only (Php 82,250.00) is the lowest calculated quotation;

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant;


WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof;






