## **INVITATION TO BID**

### **PROCUREMENT OF WORKS FOR THE CONSTRUCTION OF TUBURAN – STA. BARBARA PUMP IRRIGATION PROJECT (PIP)(REBID)**

1. The Department of Agriculture-Western Visayas, through the **General Appropriations Act of 2022**, intends to apply the sum of **Three Million Nine Hundred Sixty Thousand Three Hundred Ninety-Six Pesos and 04/100 (Php 3,960,396.04)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Works for the Construcion of Tuburan – Sta. Barbara Pump Irrigation Project (PIP)(Rebid)/IB No. 2022-043(AMV)** to be constructed at Brgy. Tuburan, Sta. Barbara, Iloilo.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Works for the Construcion of Tuburan – Sta. Barbara Pump Irrigation Project (PIP)(Rebid)** with the following specifications:

**5 Sets Pump and Engine:**

**A. Pump:**

4 inches Ø Pump and Engine Set  
Head: 20m (Minimum)  
Discharge: 15 lps (Minimum)  
Type and Size: Centrifugal  
Single-End Suction  
Self-Priming  
100mm x 100mm  
Semi-open (Impeller)

**B. Engine (Prime Mover):**

Brand New  
8.0 hp (Minimum)  
Water-cooled Diesel Engine, Direct Injection  
Must be available in the local market for at least thirty (30) years.  
With set of manufacturer's standard tools required for maintenance

**C. Accessories (3 Sets):**

Steel Base with Handle  
4 inches (diameter) elbow with hose adaptor  
4 x 2 B Pulley  
2 pcs B-size Belts

**\*Note: Two (2) sets** of Pump and Engine will be used for the structure while the remaining **three (3) sets (including accessories)** will be handed-over to the recipient/farmers' association

### **Additional Requirements:**

1. AMTEC Tested:  
Coupled – Pump and \*Engine and Pump  
Individual - \*Engine (\*the same model)
2. With reflectorized DA Western Visayas logo (minimum of 6” diameter)
3. Warranty period: one (1) year from the date of acceptance of the recipient/beneficiary
4. The brand offered for the prime mover must be available in the local market for at least thirty (30) years
5. Service center must conform to PAES 138:2004 and should have available spare parts and technician within Region 6
6. Must have a valid Certificate of Accreditation from National Agricultural and Fisheries Machinery Assemblers, Manufacturers, Importers, Distributors and Dealers Accreditation and Classification (NAMDAC) Board
7. Must have a valid Permit to Operate (PTO)
8. Must have a valid Certificate of Conformity (CC) for Engine offered

Completion of the Works is required **within 95 calendar days** from receipt of Notice to Commence. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

8. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
9. Interested bidders may obtain further information from Department of Agriculture-Western Visayas and inspect the Bidding Documents at the address given below from **8:00 a.m. to 5:00 p.m.**
10. A complete set of Bidding Documents may be acquired by interested bidders on **June 15 – July 06, 2022** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person**.
11. The Department of Agriculture-Western Visayas will hold a Pre-Bid Conference<sup>1</sup> at **1:00 p.m.** on **June 22, 2022** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Brgy. Buntatala, Jaro, Iloilo City**, which shall be open to prospective bidders.
12. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below or **online or electronic (pdf file) submission** as indicated below, on or before **1:00 p.m.** on **July 06, 2022**. Late bids shall not be accepted.
13. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount of **Php 79,207.95** (if the bid security is in the form of cash, cashier’s/manager’s check, bank draft/guarantee or irrevocable letter of credit) or **Php 198,019.85** (if the bid security is in the form of surety bond).

<sup>1</sup> May be deleted in case the ABC is less than One Million Pesos (Php1,000,000) where the Procuring Entity may not hold a pre-bid conference.

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

14. Bid opening shall be at **1:00 p.m.** on **July 06, 2022** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
15. The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
16. The **Department of Agriculture** does not condone any forms of solicitation on any prospective winning and losing bidders by any of our staff/employees or any other party. Any sort of this kind shall be reported immediately to the Office of the Secretary or the National Bureau of Investigation (NBI) for entrapment and proper investigation.
