The **Department of Agriculture-Western Visayas**, through the **General Appropriations Act of 2022** intends to apply the sum of **Fourteen Million Three Hundred Ten Thousand Pesos (Php14,310,000.00)** being the ABC to payments under the contract for **Procurement of Supply and Delivery of Layer Poultry Package (by Lot)/IB 2022-55 (GAS)**.

- Either Lohmann, Dekalb or other commercial layer strains
- At least 36 heads ready-to-lay pullets per set, completely dewormed and vaccinated against New Castle Disease, Infectious Bursal Disease, Infectious Bronchitis, Coryza, Fowl Pox, Fowl Cholera and Egg Drop Syndrome certified by a Licensed Veterinarian
- Negative RT-PCR test result from origin for Avian Influenza if sourced from outside Region 6

Bidders should have completed, within three (3) years (**2019-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

Prospective Bidders may obtain further information from **Department of Agriculture-Western Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m**.

Late bids shall not be accepted. In case of online submission, submission shall follow the provision GPPB Reso. No. 09-2020 Section 4.2.

Any sort of this kind shall be reported immediately to the office of the Secretary or the National Bureau of Investigation (NBI) for entrapment and proper investigation.
