This Addendum is issued to modify or amend items in the Bid Document (Invitation to Bid, Philippine Bidding Documents and Checklist of Eligibility & Technical Requirements for the BAC – First Envelope) for **Procurement of Supply and Delivery of Unmanned Aerial System inclusive of Training and After Sales Service – IB No. 2022-047(AMV)**.

On Invitation to Bid and Philippine Bidding Documents:

2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of Unmanned Aerial System inclusive of Training and After Sales Service** with the following specifications:

Additional Requirements:

1. Supplier must have an active CAAP Operator Certificate for operating a drone business.
2. Supplier must **have be** a certificate of authorized dealership and **recognized** training partner of the manufacturer.
3. Supplier must **have a certificate of commitment that the supplier will conduct provide** training on the **use operation** and deployment of the multipurpose drone **(1 team per set)**
4. Supplier must **provide** **have a certificate of commitment that the supplier will** assistance **for in** the acquisition of UAV Controller certificate and/or registration from CAAP
5. Supplier must have **documentary proof showing** at least **two (2) years one (1) year** of experience on the use of drones for agriculture purposes and must present a hardcopy of a manual on the use of drones for agriculture in the Philippines.
6. Must have **documentary proof showing at least one (1) year** of experience in supporting and maintaining drones used in agriculture **within the last two (2) years one (1) year**.

Delivery of the Goods is required within **30 60** calendar days from receipt of Notice to Commence and to be delivered in **DA Operations Building, BPI Compound, Pepita Aquino Avenue, Concepcion, Iloilo City**.

- i) Certificate of commitment that supplier will assist in the acquisition of UAV Controller certificate and/or registration from CAAP

- j) Documentary proof showing at least one (1) year of experience on the use of drones for agriculture purposes and must present a hardcopy of a manual on the use of drones for agriculture in the Philippines.

- k) Documentary proof showing at least one (1) year of experience in supporting and maintaining drones used in agriculture.

Failure of the Bidder declared as Lowest Calculated Bid to duly submit the above requirements or a finding against the veracity of such shall be ground for forfeiture of the bid security and disqualify the Bidder for the award.
