WHEREAS, the Department of Agriculture RFO VI advertised the Invitation to bid for the **Procurement of Works for the Rehabilitation of Batuan SWIP** in the DA RFO VI website, in PhilGEPS website and a conspicuous place at the premises of DA RFO VI continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 19,602,970.30**;

WHEREAS, in response to the said advertisement, there were two (2) bidders that submitted their application for eligibility and bid offer;

WHEREAS, the two (2) bidders "passed" the preliminary examination of bids;

WHEREAS, the bid proposals of the eligible bidders were found to be substantially complying:


