WHEREAS, the Department of Agriculture has a Purchase Request Community participation to be rendered in the conduct of the project titled **“NextGen PLUS – Participatory Performance Testing and Validation (NGP-PPTV)” 2022 WS** on Rainfed Lowland (Inbred) Ecosystem to be conducted at Brgy. WHEREAS, RESTITUTO P. PANIZALES represented a community labor group responded to the Request for Quotation with the following bid offer/specifications;



- b. To recommend for approval of the award by the Regional Executive Director of the Department of Agriculture RFO 6 the foregoing findings.


