



INVITATION TO BID

PROCUREMENT OF SUPPLY AND DELIVERY OF UNMANNED AERIAL SYSTEM INCLUSIVE OF TRAINING AND AFTER SALES SERVICE (REBID)

1. The **Department of Agriculture-Western Visayas**, through the **General Appropriations Act of 2021** intends to apply the sum of **Three Million Eight Hundred Thousand Pesos (Php 3,800,000.00)** being the ABC to payments under the contract for **Procurement of Supply and Delivery of Unmanned Aerial System inclusive of Training and After Sales Service (Rebid)/IB No. 2022-050 (AMV)**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of Unmanned Aerial System inclusive of Training and After Sales Service** with the following specifications:

A. Two (2) Units 2-in-1 Multi-Rotor UAV (Spraying and Sowing)

- Tank Capacity: minimum of 20L-30L Payload
- Minimum of Six (6) Rotors
- Efficiency/hour: at least 8-16ha/hour
- Speed limit: at least 2 to 10 m/s

Additional Requirements:

1. Supplier must have an active CAAP Operator Certificate for operating a drone business.
2. Supplier must have a certificate of authorized dealership and training partner of the manufacturer.
3. Supplier must have a certificate of commitment that the supplier will conduct training on the operation and deployment of the multipurpose drone.

4. Supplier must have a certificate of commitment that the supplier will assist in the acquisition of UAV Controller certificate and/or registration from CAAP.
5. Supplier must have documentary proof showing at least one (1) year of experience on the use of drones for agriculture purposes and must present a hardcopy of a manual on the use of drones for agriculture in the Philippines.
6. Must have documentary proof showing at least one (1) year of experience in supporting and maintaining drones used in agriculture.

Delivery of the Goods is required within **60 calendar days** from receipt of Notice to Commence and to be delivered in **DA Operations Building, BPI Compound, Pepita Aquino Avenue, Concepcion, Iloilo City**.

Bidders should have completed, within **three (3) years (2019-2021)** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

4. Prospective Bidders may obtain further information from **Department of Agriculture - Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 15 – September 5, 2022** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.
6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference¹ at **1:00 p.m. on August 22, 2022** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Brgy. Buntatala, Jaro, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual** submission at the office address indicated below or **online or electronic** (pdf file) submission as indicated below, on or before **1:00 p.m. on September 5, 2022**. Late bids shall not be accepted.
8. All Bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the amount of **Php 76,000.00** (if the bid security is in the form of cash, cashier’s/manager’s check, bank draft/guarantee or irrevocable letter of credit) **or** **Php 190,000.00** (if the bid security is in the form of surety bond).

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

9. Bid opening shall be at **1:00 p.m. on September 5, 2022** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Agriculture - Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
11. The **Department of Agriculture** does not condone any forms of solicitation on any prospective winning and losing bidders by any of our staff/employees or any other party. Any sort of this kind shall be reported immediately to the Office of the Secretary or the National Bureau of Investigation (NBI) for entrapment and proper investigation.
