

RESOLUTION NO. 691
Series of 2022

WHEREAS, the agency has an original project, Procurement of Supply and Delivery of bio-fertilizers with nutrient content of Carrageenan based foliar fertilizer with an Approved Budget for the Contract (ABC) of Nineteen Million Three Hundred Seventy Thousand Seven Hundred Pesos (Php19,370,700.00);

WHEREAS, the Bids and Awards Committee (BAC) for Goods and Services has issued a Resolution No. 2022-104 dated May 10, 2022 recommending the award of contract to Aves Farm Supply and General Merchandise as Lowest Calculated and Responsive Bidder amounting to Sixteen Million One Hundred Forty-Two Thousand Two Hundred Fifty Pesos (Php 16,142,250.00);

WHEREAS, the BAC Resolution was approved by the Head of the Procuring Entity and a Notice to Proceed was issued and received by Aves Farm Supply and General Merchandise on June 1, 2022;

WHEREAS, a Purchase Request (PR) to procure 12,913 liter of Carrageenan based foliar fertilizers with an ABC of Three Million Two Hundred Twenty Eight Thousand Two Hundred Fifty Pesos (Php 3,228,250.00) was made to utilize the savings out of the Nineteen Million Three Hundred Seventy Thousand Seven Hundred Pesos (Php19,370,700.00) which was generated;

WHEREAS, under Section 51, Article XVI of R.A. 9184 and its Revised Implementing Rules and Regulations and when provided for in the Annual Procurement Plan, **REPEAT ORDER** as an Alternative Method of Procurement may be allowed wherein the Procuring Entity directly procure GOODS from the previously contracted winning bidder under the following conditions;

- a. The unit price offered by Aves Farm Supply and General Merchandise under Repeat Order is equal to or lower than that provided in the original contract;
- b. The repeat order does not result in splitting of requisitions or purchase orders;
- c. The repeat order is availed of within six (6) months from the date of the Notice to Proceed arising from the original contract wherein partial delivery, inspection and acceptance of the goods was already made; and
- d. The repeat order does not exceed twenty-five percent (25%) of the quantity of each item of the original contract.

THEREFORE, subject to post-qualification process, the Bids and Awards Committee for Goods and Services RESOLVE as it is hereby RESOLVED that **REPEAT ORDER** shall be the mode of procurement in favor of Aves Farm Supply and General Merchandise for the procurement of 12,913 liter of Carrageenan based foliar fertilizers.


