**WHEREAS**, the Department of Agriculture–WV has a Purchase Request for Community Participation to be rendered for the Rehabilitation of Forage Cut-and-Carry Area (Phase 2) at DA–WESVIARC, Buntatala, Jaro, Iloilo City from September 5 – October 19, 2022 with an Approved Budget for the Contract (ABC) equivalent to *Fifty-Four Thousand Six Hundred Pesos Only (Php 54,600.00)*;

**NOW, THEREFORE**, We the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED;






