

INVITATION TO BID FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF LOWLAND VEGETABLE SEEDS

- 1. The Department of Agriculture-Western Visayas, through the GAA of 2021 Plant, Plant, Plant 2 Program intends to apply the sum of Two Million One Hundred Thirty Four Thousand Six Hundred Fifty Pesos (Php2,134,650.00) being the ABC to payments under the contract for Procurement of Supply and Delivery of Lowland Vegetable Seeds/IB 2022-86 (GAS). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of Lowland Vegetable Seeds** with the following specifications:

A. Lowland Vegetable Seeds

Ampalaya 100g/can (F1 Hybrid), medium green fruits,	10.00 kgs
Resistant to maleness	
Squash 250g/can (F1 Hybrid), Flat round pumpkin varieties	37.50 kgs
Tomato 25g/can (Fusarium wilt Resistant)	5.00 kgs
Pole Sitao 1kg/pack, Smooth, dark green pods	50.00 kgs
Eggplant 50g/can (F1 Hybrid), long purple fruit, Resistant	9.00 kgs
to Backterial wilt	
Pechay 1kg/pack, Black Behi type	515.00 kgs

Terms and Conditions:

- Sourced from PSIA Accredited Seed Company
- Must be in sealed pack/can
- Packing date not earlier than last quarter of 2021
- With minimum of 85% germination rate as per BPI standard
- Must be tested at NSQCS point of origin and retested at NSQCS 6, WESVIARC, Hamungaya, Buntatala, Jaro, Iloilo City

Delivery of the Goods is required within 5 calendar days from receipt of Notice to **Proceed** and to be delivered at DA Operations Division, Parola, Iloilo City.

Bidders should have completed, within three (3) years (**2019-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

Prospective Bidders may obtain further information from **Department of Agriculture-Western Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m**.

- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 22, 2022 December 14, 2022** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.
- 6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference at **11:00 a.m.** on **December 1, 2022** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Hamungaya, Brgy. Buntatala, Jaro, Iloilo City, which shall be open to prospective bidders.**
- 7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below or **online or electronic (pdf file) submission** as indicated below, on or before **9:00 a.m.** on **December 14, 2022**. Late bids shall not be accepted. In case of online submission, submission shall follow the provision GPPB Reso. No. 09-2020 Section 4.2.
- 8. All Bids must be accompanied by a Bid Securing Declaration or Bid Security in the amount of any of the acceptable forms and in the amount of **Php42,693.00** (if the bid security is in the form of cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit) or **Php106,732.50** (if the bid security is in the form of surety bond).

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

- 9. Bid opening shall be at **9:00 a.m.** on **December 14, 2022** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
- 11. **Department of Agriculture-Western Visayas** does not condone any form of solicitation on any prospective winning and losing bidders by any of our staff/employees or any other party. Any sort of this kind shall be reported immediately to the office of the Secretary or the National Bureau of Investigation (NBI) for entrapment and proper investigation.
