



## **INVITATION TO BID FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF VARIOUS HYBRID CORN SEEDS UNDER YCPEP (BY LOT)**

1. The **Department of Agriculture-Western Visayas**, through the **National Expenditure Program of 2023** intends to apply the sum of **Forty Million Four Hundred Twenty Five Thousand Pesos (Php40,425,000.00)** being the ABC to payments under the contract for **Procurement of Supply and Delivery of Various Hybrid Corn Seeds under YCPEP (By Lot)/IB 2023-09 (GAS)**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of Various Hybrid Corn Seeds under YCPEP (By Lot)** with the following specifications:

**Lot 1 – 7,800 bags Genetically Modified Hybrid Corn Seeds @ 9kg/bag**

- NSIC Approved Genetically Modified Hybrid Yellow Corn Seeds @ 9kg/bag;
- NSIC Approved Variety not earlier than 2012;
- Resistant to Glyphosate, Corn Borer, Cutworm and Earworm;
- Date of harvest not earlier than February 2023;
- With tag specified the following: Lot number, Germination Percentage, Date of Harvest, Purity (Inert Matter) and not more than 12 percent moisture content;
- At least 85% germination percentage upon testing at NSQCS place of origin and BPI NSQCS 6 upon delivery.

**Lot 2 – 285 bags Conventional Hybrid Yellow Corn Seeds @ 18kg/bag**

- NSIC Approved Conventional Hybrid Yellow Corn @ 18kg/bag;
- Date of harvest not earlier than February 2023;
- With tag specified the following: Lot number, germination rate, date of harvest, purity, seed class not more than 12% moisture content;
- At least 85% germination percentage upon testing at NSQCS place of origin and BPI NSQCS 6 upon delivery.
- Target date of delivery: April 2023
- Place of delivery: RPC, Bago City, Negros Occidental

Terms and Conditions for Lot 1 and Lot 2:

- With the DA logo and labelled “Not for Sale”;
- Target month of planting: May to June 2023 (First Cropping);
- With the assigned personnel in Western Visayas; and
- Available at local market in Western Visayas

Delivery of the Goods is required **within 30 calendar days from receipt of Notice to Proceed.**

Bidders should have completed, within three (3) years (**2019-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

Prospective Bidders may obtain further information from **Department of Agriculture-Western Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 4, 2022 – November 28, 2022** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amount:

The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.

6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference at **9:00 a.m. on November 14, 2022** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Hamungaya, Brgy. Buntatala, Jaro, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below or **online or electronic (pdf file) submission** as indicated below, on or before **9:00 a.m. on November 28, 2022**. Late bids shall not be accepted. In case of online submission, submission shall follow the provision GPPB Reso. No. 09-2020 Section 4.2.
8. All Bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the following amount:

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

9. Bid opening shall be at **9:00 a.m. on November 28, 2022** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

11. **Department of Agriculture-Western Visayas** does not condone any form of solicitation on any prospective winning and losing bidders by any of our staff/employees or any other party. Any sort of this kind shall be reported immediately to the office of the Secretary or the National Bureau of Investigation (NBI) for entrapment and proper investigation.
