This Addendum is issued to modify or amend items in the Bid Document (*Invitation to Bid, Philippine Bidding Documents and Checklist of Eligibility & Technical Requirements for the BAC – First Envelope*) for **Procurement of Supply and Delivery of Eleven (11) Sets Pump and Engine/IB No. 2023-019(AMV)**.

 - c.3 Copy of the license of the surety firm, in case surety bond is filed.
