Lease of Venue with food and accommodation during the conduct of Complementation Activities with partner PLGUs and FCAs: Planning and Year End Assessment on February 16-17, 2023

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with food and accommodation during the conduct of Complementation Activities with partner PLGUs and FCAs: Planning and Year End Assessment on February 16-17, 2023 with an Approved Budget for the Contract (ABC) of Seventy Six Thousand Eight Hundred Pesos Only (Php 76,800.00).

WHEREAS, on Jan. 27, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) HOTEL METRO SKY BAR & RESTAURANT; (2) AGZAM RESORT AND SPA MANAGEMENT CORPORATION; (3) ATI-ATIHAN FESTIVALHOTEL.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on Feb. 3, 2023, HOTEL METRO SKY BAR & RESTAURANT, AGZAM RESORT AND SPA MANAGEMENT CORPORATION, and ATI-ATIHAN FESTIVALHOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, AGZAM RESORT AND SPA MANAGEMENT CORPORATION is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, the TWG likewise determined that the financial proposal submitted by AGZAM RESORT AND SPA MANAGEMENT CORPORATION in the amount of Seventy Four Thousand Seven Hundred Twenty Pesos Only (Php 74,720.00) is the lowest quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Lease of Venue with food and accommodation during the conduct of Complementation Activities with partner PLGUs and FCAs: Planning and Year End Assessment on February 16-17, 2023 to AGZAM RESORT AND SPA MANAGEMENT CORPORATION in the amount of Seventy Four Thousand Seven Hundred Twenty Pesos Only (Php 74,720.00)
