



BAC Resolution No. 136, Series of 2023

**Procurement of Works for the Upgrading of Animal Housing/Shelter**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Procurement of Works for the Upgrading of Animal Housing/Shelter with an Approved Budget for the Contract (ABC) of Three Hundred Fifty Five Thousand Pesos Only (Php 355,000.00).

**WHEREAS**, on Feb. 17, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) J.C. ALBASON BUILDERS AND SUPPLY; (2) PESOM CONSTRUCTION SERVICES; (3) QUADTECH BUILDERS AND CONSTRUCTION SUPPLY.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 12:00 noon, on Feb. 24, 2023, J.C. ALBASON BUILDERS AND SUPPLY, PESOM CONSTRUCTION SERVICES, and QUADTECH BUILDERS AND CONSTRUCTION SUPPLY submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, PESOM CONSTRUCTION SERVICES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, the TWG likewise determined that the financial proposal submitted by PESOM CONSTRUCTION SERVICES in the amount of Three Hundred Fifty Four Thousand Nine Hundred Thirty One & 28/100 Pesos Only (Php 354,931.28) is the lowest quotation.

**WHEREAS**, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Procurement of Works for the Upgrading of Animal Housing/Shelter to PESOM CONSTRUCTION SERVICES in the amount of Three Hundred Fifty Four Thousand Nine Hundred Thirty One & 28/100 Pesos Only (Php 354,931.28)


