BAC Resolution No. 164, Series of 2023

**Lease of Venue with food and accommodation during the conduct of Two Batches Bantay Peste Brigade Training for Corn Cluster Areas**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of Venue with food and accommodation during the conduct of Two Batches Bantay Peste Brigade Training for Corn Cluster Areas with an Approved Budget for the Contract (ABC) of One Hundred Forty One Thousand Pesos Only (Php 141,000.00) for lot 1.

**WHEREAS**, on Mar. 21, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz:  
: (1) MO2 WESTOWN HOTEL; (2) ZURI HOTELS AND SUITES; (3) PARK INN BY RADISSON ILOILO.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 12:00 noon. on Mar. 24, 2023, MO2 WESTOWN HOTEL, ZURI HOTELS AND SUITES, and PARK INN BY RADISSON ILOILO submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, MO2 WESTOWN HOTEL is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, the TWG likewise determined that the financial proposal submitted by MO2 WESTOWN HOTEL in the amount of One Hundred Thirty Eight Thousand Pesos Only (Php 138,000.00) is the lowest quotation for lot 1.

**WHEREAS**, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Lease of Venue with food and accommodation during the conduct of Two Batches Bantay Peste Brigade Training for Corn Cluster Areas to MO2 WESTOWN HOTEL in the amount of One Hundred Thirty Eight Thousand Pesos Only (Php 138,000.00)
