**Procurement of Catering Services for the conduct of 1st Quarter Accomplishment Review for FY 2023**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Procurement of Catering Services for the conduct of 1st Quarter Accomplishment Review for FY 2023 with an Approved Budget for the Contract (ABC) of Seventy Two Thousand Pesos Only (Php 72,000.00).

**WHEREAS**, on Mar. 8, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to six (6) prospective suppliers, viz: (1) REGATTA HOTELS INC.; (2) MO2 WESTOWN HOTEL; (3) JARO BISCOCHO FOOD HOUSE; (4) FRANCISCO'S REFRESHMENT; (5) TONY'S FASTFOOD & CATERING SERVICES; (6) CK TRUMART FOODS CORP.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 12:00 noon. on Mar. 15, 2023, REGATTA HOTELS INC., MO2 WESTOWN HOTEL, JARO BISCOCHO FOOD HOUSE, FRANCISCO'S REFRESHMENT, TONY'S FASTFOOD & CATERING SERVICES and CK TRUMART FOODS CORP. submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, CK TRUMART FOODS CORP. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, the TWG likewise determined that the financial proposal submitted by CK TRUMART FOODS CORP. in the amount of Sixty One Thousand Two Hundred Pesos Only (Php 61,200.00) is the lowest quotation.

**WHEREAS**, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.
