Procurement of supply and delivery of catering services for the conduct of Stress Management Training

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of supply and delivery of catering services for the conduct of Stress Management Training with an Approved Budget for the Contract (ABC) of Eighty Thousand Five Hundred Pesos Only (Php 80,500.00).

WHEREAS, on Mar. 13, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to four (4) prospective suppliers, viz: (1) REGATTA HOTELS, INC.; (2) EON CENTENNIAL RESORT HOTEL & WATERPARK; (3) HARBOR TOWN HOTEL; (4) ZAMEO MPC

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on Mar. 16, 2023, REGATTA HOTELS, INC., EON CENTENNIAL RESORT HOTEL & WATERPARK, HARBOR TOWN HOTEL and ZAMEO MPC submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ZAMEO MPC is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, the TWG likewise determined that the financial proposal submitted by ZAMEO MPC in the amount of Seventy Four Thousand One Hundred Seventy Five Pesos Only (Php 74,175.00) is the lowest quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Procurement of supply and delivery of catering services for the conduct of Stress Management Training to ZAMEO MPC in the amount of Seventy Four Thousand One Hundred Seventy Five Pesos Only (Php 74,175.00)
