



RESOLUTION NO. 225

**WHEREAS**, the agency has an original project, Procurement of Supply and Delivery of Genetically Modified Hybrid Yellow Corn Seeds @9kg/bag with an Approved Budget for the Contract (ABC) of Four Million Six Hundred Fifteen Thousand Pesos (Php4,615,000.00);

**WHEREAS**, the Bids and Awards Committee (BAC) for Goods and Services has issued a Resolution No. 2022-185 dated November 10, 2022 recommending the award of contract to Model Agro Sales in the amount of Three Million Two Hundred Seventy-Six Thousand Six Hundred Fifty Pesos (Php3,276,650.00);

**WHEREAS**, the BAC Resolution was approved by the Head of the Procuring Entity and a Notice to Proceed was issued and received by Model Agro Sales on December 6, 2022;

**WHEREAS**, a Purchase Request (PR) for the Procurement of Supply and Delivery of Genetically Modified Hybrid Yellow Corn Seeds @9kg/bag with an ABC of Eight Hundred Sixteen Thousand Five Hundred Pesos (Php816,500.00) was made to utilize the savings out of One Million Three Hundred Thirty-Eight Thousand Three Hundred Fifty Pesos (Php1,338,350.00);

**WHEREAS**, under Section 51, Article XVI of R.A. 9184 and its Revised Implementing Rules and Regulations and when provided for in the Annual Procurement Plan, **REPEAT ORDER** as an Alternative Method of Procurement may be allowed wherein the Procuring Entity directly procure GOODS from the previously contracted winning bidder under the following conditions;


- a. The unit price offered by Model Agro Sales under Repeat Order is equal to or lower than that provided in the original contract;
- b. The repeat order does not result in splitting of requisitions or purchase orders;
- c. The repeat order is availed of within six (6) months from the date of the Notice to Proceed arising from the original contract wherein partial delivery, inspection and acceptance of the goods was already made; and
- d. The repeat order does not exceed twenty-five percent (25%) of the quantity of each item of the original contract.

**THEREFORE**, subject to post-qualification process, the Bids and Awards Committee for Goods and Services RESOLVE as it is hereby RESOLVED that **REPEAT ORDER** shall be the mode of procurement in favor of Model Agro Sales for the Procurement of Supply and Delivery of Genetically Modified Hybrid Yellow Corn Seeds @9kg/bag.


