BAC Resolution No. 324, Series of 2023

Procurement of Supply and Delivery of Farm Supplies

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Farm Supplies with an Approved Budget for the Contract (ABC) of One Hundred Thirty Three Thousand Pesos Only (Php 133,000.00).

WHEREAS, on Mar. 20, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to four (4) prospective suppliers, viz: (1) RS AGRO INDUSTRIAL CORP.; (2) P & A FARM SUPPLY; (3) PANAY AGRO CENTER CORP.; (4) JUANTONG AGRI-VENTURES, INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on Mar. 27, 2023, RS AGRO INDUSTRIAL CORP., P & A FARM SUPPLY, PANAY AGRO CENTER CORP. and JUANTONG AGRI-VENTURES, INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, RS AGRO INDUSTRIAL CORP. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, the TWG likewise determined that the financial proposal submitted by RS AGRO INDUSTRIAL CORP. in the amount of One Hundred Twenty Thousand Two Hundred Forty Five Pesos Only (Php 120,245.00) is the lowest quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Procurement of Supply and Delivery of Farm Supplies to RS AGRO INDUSTRIAL CORP. in the amount of One Hundred Twenty Thousand Two Hundred Forty Five Pesos Only (Php 120,245.00)
