

BAC Resolution No. 294, Series of 2023

Lease of Venue with food and accommodation during the conduct of Social Preparation and F2C2 Program Re-Orientation

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with food and accommodation during the conduct of Social Preparation and F2C2 Program Re-Orientation with an Approved Budget for the Contract (ABC) of Five Hundred Sixty Four Thousand Pesos Only (Php 564,000.00).

WHEREAS, on April 14, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: : (1) EON CENTENNIAL RESORT HOTEL & WATERPARK; (2) DISTRICT 21 HOTEL; (3) MO2 WESTOWN HOTEL.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on April 18, 2023, EON CENTENNIAL RESORT HOTEL & WATERPARK, DISTRICT 21 HOTEL, and MO2 WESTOWN HOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, EON CENTENNIAL RESORT HOTEL & WATERPARK is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, the TWG likewise determined that the financial proposal submitted by EON CENTENNIAL RESORT HOTEL & WATERPARK in the amount of Five Hundred Twenty Eight Thousand Pesos Only (Php 528,000.00) is the lowest quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Lease of Venue with food and accommodation during the conduct of Social Preparation and F2C2 Program Re-Orientation to EON CENTENNIAL RESORT HOTEL & WATERPARK in the amount of Five Hundred Twenty Eight Thousand Pesos Only (Php 528,000.00)
