

BAC Resolution No. 59, Series of 2023

Lease of Venue with Food and Accommodation during the Conduct of Corn and Cassava Cluster

Development Training

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation during the Conduct of Corn and Cassava Cluster Development Training with an Approved Budget for the Contract (ABC) of Three Hundred Thirty Seven Thousand Five Hundred Pesos Only (Php 337,500.00).

WHEREAS, on May 12, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: (1) MO2 WESTOWN HOTEL; (2) DISTRICT 21 HOTEL; (3) EON CENTENNIAL RESORT HOTEL & WATERPARK.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on May 19, 2023, MO2 WESTOWN HOTEL, DISTRICT 21 HOTEL, and EON CENTENNIAL RESORT HOTEL & WATERPARK submitted their quotations.

requirements and specification stated in the Request for Quotation, EON CENTENNIAL RESORT HOTEL & WATERPARK is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

EON CENTENNIAL RESORT HOTEL & WATERPARK in the amount of Three Hundred Thirty Thousand Pesos Only (Php 330,000.00) is the lowest quotation.

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG. hereby resolve to recommend to the HOPE. for her consideration and approval, the award of contract for the Lease of Venue with Food and Accommodation during the Conduct of Corn and Cassava Cluster Development Training to EON CENTENNIAL RESORT HOTEL & WATERPARK in the amount of Three Hundred Thirty Thousand Pesos Only (Php 330.000.00)
