WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the Procurement of Supply and Delivery of Heavy-Duty Good Quality Garden Tools in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php 1,297,750.00;

WHEREAS, in response to the said advertisement, three (3) bidders submitted its application for eligibility and bid offer;

WHEREAS, the three (3) bidders "passed" the preliminary examination of bid;

WHEREAS, the bid proposal of the three (3) bidders were found to be substantially complying:




