



BAC Resolution No. 250, Series of 2023

**Lease of Venue with Food and Accommodation during the conduct of Sagip Saka Preparation for Capacity Development Plan**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation during the conduct of Sagip Saka Preparation for Capacity Development Plan with an Approved Budget for the Contract (ABC) of Ninety Six Thousand Pesos Only (Php 96,000.00).

**WHEREAS**, on Feb. 24, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to five (5) prospective suppliers, viz: (1) RAYMEN BEACH RESORT CORP.; (2) ALOBIJOD COVE RESORT; (3) FATIMA FARM RESORT; (4) NUEVA VALENCIA MPC; (5) STAR GAZER INN

**WHEREAS**, before the lapse of the deadline for submission of quotation at 12:00 noon. on Mar. 3, 2023, RAYMEN BEACH RESORT CORP., ALOBIJOD COVE RESORT, FATIMA FARM RESORT, NUEVA VALENCIA MPC and STAR GAZER INN submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, STAR GAZER INN is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, the TWG likewise determined that the financial proposal submitted by STAR GAZER INN in the amount of Ninety Five Thousand Four Hundred Pesos Only (Php 95,400.00) is the lowest quotation.

**WHEREAS**, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for her consideration and approval, the award of contract for the Lease of Venue with Food and Accommodation during the conduct of Sagip Saka Preparation for Capacity Development Plan to STAR GAZER INN in the amount of Ninety Five Thousand Four Hundred Pesos Only (Php 95,400.00)
