WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of supply and delivery of food for the conduct of various specialized trainings with an Approved Budget for the Contract (ABC) of One Hundred Eighty Nine Thousand Pesos Only (Php 189,000.00).

WHEREAS, on May 2, 2023, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, viz: : (1) IBON MPC; (2) FOUR SNACK HOUSE; (3) HOTEL METRO AND SKYBAR RESTAURANT

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on May 9, 2023, IBON MPC, FOUR SNACK HOUSE and HOTEL METRO AND SKYBAR RESTAURANT submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, FOUR SNACK HOUSE is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2023 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, the TWG likewise determined that the financial proposal submitted by FOUR SNACK HOUSE in the amount of One Hundred Seventy Six Thousand Four Hundred Pesos Only (Php 176,400.00) is the lowest quotation.
