BAC Resolution No. 11

WHEREAS, the Department of Agriculture Western Visayas has a Purchase Request for the labor and materials for the rehabilitation of electrical system at DA-WESVIARC, Buntatala, Jaro, Iloilo City with a total Approved Budget for the Contract under GAA 2023 in the amount of Four Hundred Twenty-Three Thousand Six Hundred Sixty-Six Pesos only;

WHEREAS, on June 5, 2023, an incident of melting of secondary line connecting the transformer to the main breaker at the power house occurred;

WHEREAS, an emergency restoration has been done just to restore electrical power without any rehabilitation on the existing system;

WHEREAS, after inspection and initial investigation on the incident, overloading due to unbalance load that may have caused;

WHEREAS, recommendations/options considered were: Load balancing, construction of transformer pad and upgrading of wire size;

WHEREAS, typhoon Goring caused heavy rain, flooding and electrical failures at electrical system serving the residential areas of WESVIARC Compound, Buntatala, Iloilo City;

WHEREAS, that there is a possibility that some electrical lines serving WESVIARC compound offices were affected too and may cause faulty or grounded lines;

WHEREAS, on August 30, 2023, it was observed that insulators of the main line from transformer to the main breaker has started to melt;

WHEREAS, there is a need to an immediate restoration of electrical wire before it will cause further inconvenience or may induce fire;

WHEREAS, there is a need to resort to Negotiated Procurement-Emergency Cases pursuant to Section 53.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184;

WHEREAS, in Section 53.2 states that in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities. The instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To recommend the Negotiated Procurement Emergency Cases for labor and materials for the rehabilitation of electrical system at DA-WESVIARC, Buntatala, Jaro, Iloilo City;
- To recommend the award for contract for labor and materials for the rehabilitation of electrical system at DA-WESVIARC, Buntatala, Jaro, Iloilo City to NOE'S BUILDERS in the amount of Four Hundred Twenty-Three Thousand Six Hundred Sixty-Six Pesos only;
- To recommend for approval by the Regional Executive Director of the Department of Agriculture-Western Visayas the foregoing findings.
