INVITATION TO BID FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF 3,045 BAGS NSIC APPROVED HYBRID RICE SEEDS

- 1. The **Department of Agriculture-Western Visayas**, through the **General Appropriations Act of 2023** intends to apply the sum of **Fifteen Million Two Hundred Twenty Five Thousand Pesos** (**Php15,225,000.00**) being the ABC to payments under the contract for **Procurement of Supply and Delivery of 3,045 bags NSIC Approved Hybrid Rice Seeds/IB 2023-89(GAS)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of 3,045 bags NSIC Approved Hybrid Rice Seeds** with the following specifications:

Delivery of the Goods is required within 30 calendar days from receipt of Notice to **Proceed** and to be delivered at WESVIARC, Hamungaya, Brgy. Buntatala, Jaro, Iloilo City.

Bidders should have completed, within three (3) years (**2020-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of Bidding Documents may be acquired by interested Bidders on **October** 5, 2023 **October** 25, 2023 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos** (**Php25,000.00**). The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.
- 6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference at **1:30 p.m.** on **October 13, 2023** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Hamungaya, Brgy. Buntatala, Jaro, Iloilo City,** which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 1:30 p.m. on October 25, 2023. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a Bid Securing Declaration or Bid Security in the amount of any of the acceptable forms and in the amount of **Php304,500.00**(if the bid security is in the form of cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit) or **Php761,250.00** (if the bid security is in the form of surety bond).
 - In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.
- 9. Bid opening shall be at **1:30 p.m.** on **October 25, 2023** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
