## INVITATION TO BID FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF VARIOUS PESTICIDES

1. The **Department of Agriculture-Western Visayas**, through the **National Expenditure Program 2024** intends to apply the sum of **Two Million Pesos (Php2,000,000.00)** being the ABC to payments under the contract for **Procurement of Supply and Delivery of Various Pesticides /IB 2024-007 (GAS)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of Various Pesticides** with the following specifications:

### Fungicide

Active ingredient: Mancozeb, WP, 800g/kg concentration @ 1kg/box	500 boxes
Active ingredient: Copper hydroxide, DF, 538g/kg concentration @ 1kg/box	500 boxes

### Insecticide

Active ingredient: Bifenthrin + Clothianidin, 370 SC (247g/L + 123g/L concentration) @ 1 liter/bottle	500 bottles
Active ingredient: Carbosulfan, 200 SC, 200g/L concentration @ 1 liter/bottle	500 bottles

### Terms and Conditions:

- Must be FPA registered
- With attachment brochure of items offered
- Manufacturing date not earlier than January 2023

Delivery of the Goods is required **within 30 calendar days from receipt of Notice to Proceed** and to be delivered at DA-RCPC Building, WESVIARC, Hamungaya, Brgy. Buntatala, Jaro, Iloilo City.

Bidders should have completed, within three (3) years (**2020-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

Prospective Bidders may obtain further information from **Department of Agriculture-Western Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 30, 2023 – November 21, 2023** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.
6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference at **8:30 a.m. on November 7, 2023** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Hamungaya, Brgy. Buntatala, Jaro, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below on or before **8:30 a.m. on November 21, 2023**. Late bids shall not be accepted.
8. All Bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the amount of **Php40,000.00** (if the bid security is in the form of cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit) **or Php100,000.00** (if the bid security is in the form of surety bond).

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

9. Bid opening shall be at **8:30 a.m. on November 21, 2023** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
