## **INVITATION TO REBID FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF 259 BAGS GENETICALLY MODIFIED HYBRID YELLOW CORN SEEDS**

1. The **Department of Agriculture-Western Visayas**, through the **General Appropriations Act of 2023** intends to apply the sum of **One Million Two Hundred Ninety Five Thousand Pesos (Php1,295,000.00)** being the ABC to payments under the contract for **Procurement of Supply and Delivery of 259 bags Genetically Modified Hybrid Yellow Corn Seeds/IB 2023-98 (GAS)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of 259 bags Genetically Modified Hybrid Yellow Corn Seeds** with the following specifications:

### **259 bags Genetically Modified Hybrid Yellow Corn Seeds @ 9kg/bag**

- NSIC Approved Genetically Modified Hybrid Yellow Corn Seeds @ 9kg/bag or 389 kernels/100 grams
- NSIC Approved GM hybrid Yellow Corn Varieties preferably at least three (3) of the following divided equally per variety:
  - NSIC 2018 GMCn 54
  - NSIC 2020 GMCn 72
  - NSIC 2018 GMCn 48
  - NSIC 2019 GMCn 65
  - NSIC 2016 GMCn 41
  - NSIC 2019 GMCn 69
- Resistant to Glyphosate, Corn borer, Cutworm and Earworm
- Date of harvest not earlier than August 2023
- With tag specified the following: Lot Number, Germination Percentage, Date of harvest/Date Tested, Purity (Inert Matter) and not more than 12 percent moisture content
- At least 85% germination percentage upon testing at BPI NSQCS 6 upon delivery
- Certificate of warranty for 3 months from the date of delivery and to replace any damaged and underweight packaging upon delivery within 7 calendar days

### **Terms and Conditions:**

- With DA logo and labelled “Not for Sale” printed on the bag (see attached format)
- Must have assigned company’s Technical Expert in Western Visayas
- The supplier will issue “Certificate of Commitment or valid contract agreement under oath in case no proof of availability of supply at the time of post-qualification period

Delivery of the Goods is required **within 30 calendar days from receipt of Notice to Proceed** and to be delivered at Iloilo ROS – Cabatuan, Brgy. Banguit, Cabatuan, Iloilo.

Bidders should have completed, within three (3) years (**2020-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

Prospective Bidders may obtain further information from **Department of Agriculture-Western Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 16, 2023 – December 6, 2023** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.
6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference at **8:30 a.m. on November 24, 2023** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Hamungaya, Brgy. Buntatala, Jaro, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below on or before **8:30 a.m. on December 6, 2023**. Late bids shall not be accepted.
8. All Bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the amount of **Php25,900.00** (if the bid security is in the form of cash, cashier’s/manager’s check, bank draft/guarantee or irrevocable letter of credit) **or Php64,750.00** (if the bid security is in the form of surety bond).

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

9. Bid opening shall be at **8:30 a.m. on December 6, 2023** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
11. **Department of Agriculture-Western Visayas** does not condone any form of solicitation on any prospective winning and losing bidders by any of our staff/employees or any other party. Any sort of this kind shall be reported immediately to the office of the Secretary or the National Bureau of Investigation (NBI) for entrapment and proper investigation.
