INVITATION TO BID PROCUREMENT OF WORKS FOR THE ESTABLISHMENT OF GREENHOUSE WITH HYDROPONICS FACILITY (SOLAR POWERED) BY LOT

The Department of Agriculture-Western Visayas, through the National Expenditure Program of 2024 (Early Procurement short of Award), intends to apply the sum of Five Million Nine Hundred Forty Thousand Five Hundred Ninety Four Pesos and 06/100 (Php5,940,594.06) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Works for the Establishment of Greenhouse with hydroponics Facility (Solar Powered) By Lot/IB No. 2024 (AMV) to be constructed at Kabankalan, Negros Occidental and Badiangan, Iloilo.

Terms and Condition for Lit 1 and Lot 2:

• With assigned technical personnel to conduct operational (one cycle) training after establishment of the facility

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The Department of Agriculture-Western Visayas now invites bids for the Procurement of Works for the Establishment of Greenhouse with hydroponics Facility (Solar Powered) By Lot at Kabankalan, Negros Occidental and Badiangan, Iloilo. Completion of the Works is required within 60 calendar days per Lot from receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- 7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below on or before **8:30 a.m.** on **December 13, 2023**. Late bids shall not be accepted.
- 8. All bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the amount:

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.
