## INVITATION TO BID

### PROCUREMENT OF WORKS FOR THE CONSTRUCTION OF MUSHROOM PRODUCTION FACILITY (BY LOT)

1. The Department of Agriculture-Western Visayas, through the **National Expenditure Program of 2024 (Early Procurement short of Award)**, intends to apply the sum of **Three Million Nine Hundred Sixty Thousand Three Hundred Ninety Six Pesos and 04/100 (Php3,960,396.04)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Works for the Construction of Mushroom Production Facility/IB No. 2024-020 (AMV)** to be **constructed at Brgy. Manhayang, Sta. Barbara, Iloilo and Brgy. Lilo-an, Malinao, Aklan.**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Works for the Construction of Mushroom Production Facility** at **Brgy. Manhayang, Sta. Barbara, Iloilo and Brgy. Lilo-an, Malinao, Aklan.** Completion of the Works is required **within 80 calendar days per Lot** from receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- All bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the amount:

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

- Bid opening shall be at **8:30 a.m.** on **December 13, 2023** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
