

## CONTRACT AGREEMENT

THIS AGREEMENT is made this NOV 10 2023, 2023 between The **DEPARTMENT OF AGRICULTURE - WESTERN VISAYAS**, with office address at DA WESVIARC, Buntatala, Jaro, Iloilo City, represented herein by its Regional Executive Director, **DENNIS R. ARPIA**, and hereinafter referred to as the "ENTITY" of the one part and **Green Eco-Solution & Resources, Inc.** with address at **Blk. 15, Lot 30 Gardenville Subdivision Tangob, Bacolod City** pursuant to the laws of the Republic of the Philippines represented herein by its **Authorized Representative, ANNABELLE L. ANDRICO** and hereinafter referred to as the "SUPPLIER" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Procurement of Supply and Delivery of 2,994 heads Native Chicken** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Six Hundred Ten Thousand Seven Hundred Seventy-Two Pesos (Php 1,610,772.00)** hereinafter called "the Contract Price".

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum **One Million Six Hundred Ten Thousand Seven Hundred Seventy-Two Pesos (Php 1,610,772.00)** or such other sum as may be ascertained, **Green Eco-Solution & Resources, Inc.** with address at **Blk. 15, Lot 30 Gardenville Subdivision Tangob, Bacolod City** pursuant to the laws of the Republic of the Philippines represented herein by its **Authorized Representative, ANNABELLE L. ANDRICO** and hereinafter referred to as the **"SUPPLIER"** agrees to supply and delivery of **2,994 heads Native Chicken** in accordance with his/her/its Bid.
4. The **DEPARTMENT OF AGRICULTURE - WESTERN VISAYAS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
