On Checklist of Eligibility & Technical Requirement

- 1. Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period 2020 2021-present; and
- 11. Mayor's or Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas (2022 2023). In case of JV, each party shall also submit their respective Audited Financial Statement.
