Delivery of the Goods is required **within 15 30 calendar days from receipt of Notice to Proceed** and to be delivered at Iloilo ROS – Cabatuan, Brgy. Banguit, Cabatuan, Iloilo.

Bidders should have completed, within three (3) years (~~2020~~ **2021-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

### On Checklist of Eligibility & Technical Requirement

1. Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period ~~2020~~ **2021**-present; and
11. Mayor's or Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas (~~2022~~ **2023**). In case of JV, each party shall also submit their respective Audited Financial Statement.
