## INVITATION TO BID FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF 10 UNITS HAND TRACTOR

1. The **Department of Agriculture-Western Visayas**, through the **General Appropriations Act of 2024** intends to apply the sum of **One Million Five Hundred Thousand Pesos (Php 1,500,000.00)** being the ABC to payments under the contract for **Procurement of Supply and Delivery of 10 units Hand Tractor/IB No. 2023-070 (AMV)**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of 10 units Hand Tractor** with the following specifications:

### 10 units Hand Tractor

1. Brand new
2. 60-60 transmission  
Axle: hexagonal or Circular  
Plowing capacity, single pass 1.0 ha/day (minimum) Fuel consumption during plowing: 2.0 L/h (maximum)  
Peak Transmission Efficiency: 85% minimum (if applicable only) Field Efficiency: Minimum 80% for pull-type  
Noise level: 95 dB (A), maximum (provision of ear muffs or any ear protective device is mandated when the noise level exceeds the minimum requirement)  
With set of manufacturer's standard tools required for maintenance  
Shall conform to PNS/PABES 234:2022, Walking-type Agricultural Tractor (Pull-type)
3. Prime mover:  
Brand New  
7.0 Hp, water-cooled diesel engine, direct injection, single-cylinder, four-stroke cycle  
Maximum power developed: 80% of the rated maximum power  
Continuous power developed: 80% of the rated maximum power Specific fuel consumption: 350g/kw-h (maximum)
4. With implements one (1) unit each:  
Disc plow (2 disc), minimum  
Comb harrow  
Moldboard-type side plow leveler
5. With cage wheel and brand-new pneumatic tires
6. With trailer one (1) ton capacity with Leaf Spring Suspension and brand-new tires

**Additional Requirements:**

1. With AMTEC test result  
 Coupled – Hand tractor and \*Engine  
 Individual - \*Engine (\*same model)
2. With reflectorized DA Western Visayas logo (minimum of 6” diameter)
3. Warranty period: 1 year from the date of acceptance of the recipient/beneficiary
4. Service center must conform to PAES 138:2004 and should have an available spare parts and technician within region 6
5. Must have a valid Certificate of Accreditation from National Agricultural and Fisheries Machinery Assemblers, Manufacturers, Importers, Distributors and Dealers Accreditation and Classification (NAMDAC) Board.
6. Must have a valid Permit to Operate (PTO)
7. Must have a valid Certificate of Conformity (CC) for the engine offered

Delivery of the Goods is required within **40** calendar days from receipt of Notice to Proceed and to be delivered at the following drop-off points:

WESVIARC, Iloilo	3 units
ROS Patnongon, Antique	1 unit
ROS La Carlota, Negros Occidental	3 units
ROS Sigma, Capiz	3 units

Bidders should have completed, within **three (3) years (2021-present)** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

4. Prospective Bidders may obtain further information from **Department of Agriculture - Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 26, 2024 – March 19, 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.
6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference<sup>1</sup> at **10:30 a.m. on March 5, 2024** at the **RCPC Library, RCPC Building, DA WESVIARC Compound, Brgy. Buntatala, Jaro, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual** submission at the office address indicated below on or before **9:30 a.m. on March 19, 2024**. Late bids shall not be accepted.
8. All Bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the amount of **Php30,000.00** (if the bid security is in the form of cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit) **or Php75,000.00** (if the bid security is in the form of surety bond).  
  
In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.
9. Bid opening shall be at **9:30 a.m. on March 19, 2024** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
